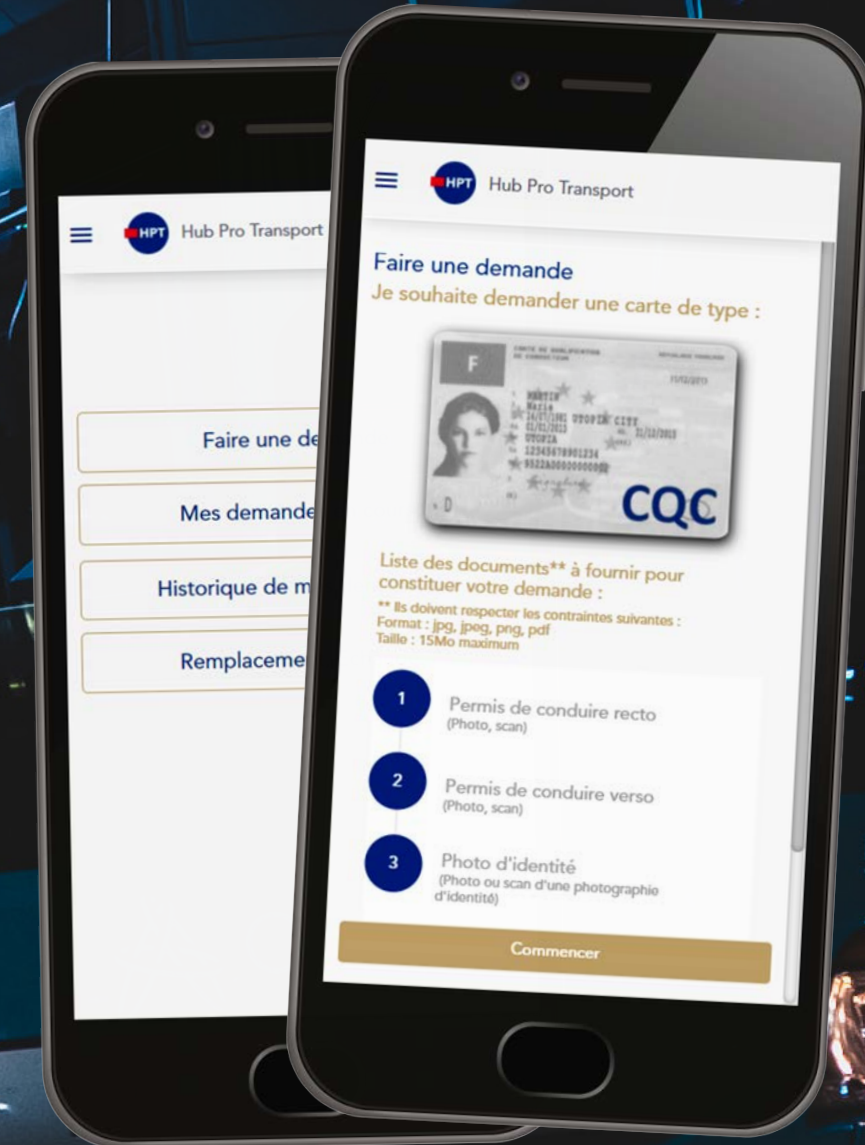
## Mobile Wallet for Credentials
