

Agnès Diallo is appointed Chairwoman of IN Groupe

By decree of the President of the French Republic dated May 15th, 2025, Agnès Diallo, CEO of IN Groupe since July 2024, is appointed Chairwoman of the company.

Agnès Diallo - Biography

Agnès Diallo has been the CEO of IN Groupe since July 2024. She has held executive positions for over 20 years in both private and public sector groups, as well as in institutional organizations in France and Europe. Her expertise spans digital transformation and trusted digital services to industrial operations and the management of large strategic projects.

At the beginning of 2023, Agnès Diallo joined the European agency eu-LISA as Executive Director. eu-LISA is responsible for information systems related to security, border control, and judicial cooperation within the Schengen area. During her tenure, she developed interoperable platforms at the core of the Schengen area's digitalization, particularly the Entry/Exit System (EES), one of the most advanced border management systems in the world.

Before that, Agnès Diallo served as Executive Vice President and member of the Executive Committee at IN Groupe from 2019 to 2022, first heading the Group's Digital Services division and later as Director of Strategy, M&A, and Performance. Previously she held executive roles in a major digital group and was a managing director at a leading international business strategy consulting firm.
